RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT Cedar Livestock and Heritage Festival

IN CONSIDERATION of being permitted to participate in the Cedar Livestock & Heritage Festival and/or other activities relating to the Parade/display in the Cedar Livestock & Heritage Festival (hereinafter referred to as the Parade/display), I, for myself, my organization, my fellow members of this organization, and their employees, agents, successors, assigns, heirs and next of kin: (hereinafter referred to as the Parade/display Entry).

- 1. HEREBY RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE, the Parade/display, the City of Cedar City, Event Coordinating Committee, the Parade/display committee, Parade/display sponsors and/or any or all Parade/display participants and the directors, officers, employees or agents of any of the foregoing (hereinafter referred to as Releases), from all liability to me, my personal representatives, assigns, heirs, and next of kin for any and all loss or damage, and any claim or demands therefore on account of injury to my person or property or resulting in death, whether caused by the negligence of the Releases or otherwise while I am observing, working for, or participating in the Parade/display (including, but not limited to, all preparations therefore, the Parade/display itself, all incidental activities including pre-parade/display and post-Parade/display activities, and the return of Parade/display materials to storage locations);
- 2. HEREBY AGREE TO INDEMNIFY AND SAVE AND HOLD HARMLESS the Releases and each of them from any loss, liability, damage, or costs they may incur due to my presence in any way observing, or working for, or participating in the Parade/display (including, but not limited to, all preparation therefore, the Parade/display itself, all incidental activities including pre-Parade/display and post Parade/display activities, and the return of Parade/display materials to storage locations, and whether caused by the negligence of the Releases or otherwise.
- 3. HEREBY ASSUME FULL RESPONSIBILITY FOR ANY RISK OF BODILY HARM, DEATH OR PROPERTY DAMAGE due to the negligence of Releases or otherwise while observing, or working for, or participating in the Parade/display (including but not limited to, all preparation therefore, the Parade/display itself, all incidental activities including pre-Parade/display and post-Parade/display activities, and the return of Parade/display materials to storage locations). I expressly acknowledge and agree that the activities of the Parade/display (including but not limited to, all preparation therefore, the Parade/display itself, all incidental activities including pre-Parade/display and post-Parade display activities, and the return of Parade/display materials to storage locations) are dangerous and involve the risk of serious injury and/or death and/or property damage. I further expressly agree that the foregoing release, waiver, and indemnity agreement is intended to be as broad and inclusive as is permitted by the laws of the State of Utah, and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, in full

legal force and effect.

I HAVE READ AND VOLUNTARILY SIGN THE RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT, and further agree that no oral representations, statements, or inducements apart from the foregoing written agreement have been made, and that this Release is being relied upon by the Parade/display in permitting my organization to participate in this Parade/display. THE PRACTICE OF THROWING CANDY TO THE PARADE SPECTATORS IS PROHIBITED.

You are MORE THAN WELCOME to have people walk alongside your entry and HAND candy out to people. Those that desire to do so, MUST walk alongside of their float/entry between the white line on the pavement and the curb.

RULES, ROUTE AND SAFETY REQUIREMENTS

Cedar Livestock and Heritage Festival

ENTRY INFORMATION - We ask that you read through the following rules and safety requirements before filing out and returning your application!

- 1. The parade/display will take place on Saturday, **October 28, 2023 at 10:00**, RAIN, SNOW OR SHINE.
- 2. Entry applications must be received on or before Friday, October 20, 2023.
- 3. Maximum height for entries is thirteen feet, 6 inches from the ground.
- 4. All entries should be properly identified with signs or banners with the organization's name on the entry so spectators know who you are.
- 5. Equestrian and animal units must provide their own accompanying clean-up personnel and equipment.
- 6. All entries should have A WESTERN THEME.
- 7. No political advertisement or politically motivated entries will be accepted.
- 8. The committee reserves the right to reject any entry that is not in good taste, is inappropriate, or is not in the best interest of the Parade/display.
- 9. All Parade/display participants are required to conduct themselves in such a manner as to not infringe on the rights of those people living in and along the staging areas and parade/display route.

SAFETY/LIABILITY

- 1. There will be no fueling of generators during the Parade/display route or fuel cans (gasoline, fuel oil, etc.) allowed on board Parade display floats.
- 2. There will be no live fires on any floats including wood stoves.
- 3. There will be no vision obstructions to tow vehicles. An observer other than the driver is required with all towed entries. The observer can walk or ride.
- 4. All children must have adult supervision.
- 5. Throwing of favors *IS NOT* allowed.
- 6. For your safety, floats/vehicles shall be brought to a complete stop before participants climb on or off the vehicle. Only emergency stops shall be allowed during the procession.
- 7. The travel speed in the Parade/display route shall be the average walking speed or approximately 3 miles per hour. A distance of 20-30 feet shall be maintained between other entries.
- 8. No explosives or fireworks of any kind shall be allowed during the parade/display. Any entries that are exceptionally noisy (horns, antique muskets, sirens, etc.) must be noted on the application.
- 9. A Release and Waiver of Liability and Indemnity Agreement form must be

signed by every unit in the parade/display. An announcer=s form must be completed.

PARADE/DISPLAY ROUTE/STAGING AREA

- 1. The Parade/display staging area is between 400 South and 200 South, Cedar City, Utah (WEST SIDE OF MAIN STREET). Check in starts at 8:00 a.m. and lineup must conclude BEFORE 9:00 a.m. Suggested access for parade/display morning is on South Main.
- 2. The Parade/display will begin at 400 South and Main and travel down Historic Main Street.
- 3. Because of congestion in the staging area, only those vehicles registered in the actual Parade/display will be permitted in the staging area.
